



## Mayors and Council Members Department Executive Committee State League Director Application

### **APPLICATIONS DUE MONDAY, AUGUST 8, 2016**

#### **Background**

The Mayors and Council Members Department of the League of California Cities is accepting applications for a State League Director from the SOUTH who will represent the Department on the League's Board of Directors for a term of two years. The vacancy will be filled at the Annual Conference in Long Beach in October. The Department Executive Committee is comprised of a President, First Vice President, Second Vice President and Immediate Past President (all one-year terms) and a State League Director (two-year term). The State Board Director position is rotated every two years between an elected official from Northern California and Southern California. **According to the current rotation, we are seeking State Director applicants from the South.**

#### **Qualifications**

The Nominating Committee will use the following information as a basis for selection:

- The individual's professional reputation;
- The individual's perspective on city service;
- Whether the individual has demonstrated a commitment to serving and strengthening the Department;
- The individual's depth of knowledge of and experience with city government;
- The individual's involvement in intergovernmental activities.

#### **Role and Responsibility and Term of Office**

The State League Director serves a term of two years and shall represent the Department on the Board of Directors of the League. The State League Director shall keep the Department membership informed of League Board activities and serve as a liaison between the Department and the League Board. In addition, the individual is a part of the leadership team of the Department and is involved in supporting the goals and work program of the Department. It is common to have other duties assigned to this position that are part of the Department's work plans for the year.

#### **The Selection Process**

Applications will be reviewed by the Nominating Committee (appointed by the current Executive Committee), and a proposed 2016/2017 Executive Committee slate will be presented for vote at Annual Conference. Nominations for this vacancy will also be open from the floor of the Department Business Meeting at Annual Conference.
