COURT REQUESTS ADDITIONAL BRIEFING IN LEAGUE'S VLF LAWSUIT TO ADDRESS PROPOSITION 30 QUESTIONS

Sacramento County Superior Court Judge Lloyd Connelly, last month, requested the parties provide additional briefing in the League's lawsuit, *League of California Cities v. Chiang*, to address the potential impacts of Proposition 30. The League's lawsuit brings constitutional challenges to SB 89/AB 118, enacted in 2011, which shifted vehicle license fee (VLF) revenues to fund public safety programs that were previously state-funded prior to SB 89/AB 118. *For more, see Page 2.*

SEN. LOIS WOLK REINTRODUCES LEGISLATION ON INFRASTRUCTURE FINANCING DISTRICTS

Monday, Dec. 3 was the first day legislation for the 2013-14 legislative session could be introduced and Sen. Lois Wolk (D-Davis) wasted no time in introducing SB 33 (Wolk), a measure to update Infrastructure Financing District law, to make it a useful tool to help cities maintain, repair, and rebuild critical infrastructure and create economic development in their communities. SB 33 is a reintroduction of last year's SB 214 (Wolk) that was supported by the League, the California Building Industry Association and other organizations. For more, see Page 2.

MUNICIPAL BOND INTEREST TAX-EXEMPTION TARGETED IN FEDERAL BUDGET DISCUSSIONS

As 2012 draws to a close, the federal government is struggling with the looming fiscal cliff. While there is bipartisan support to avoid sequestration, how to do that remains controversial. Eliminating or limiting the federal tax exemption on interest earned from municipal bonds is one particularly troublesome proposal on the table in both the fiscal cliff and future federal tax reform discussions. *For more, see Page 2*.

Proposition 30, adopted by the voters on Nov. 6, places provisions in the California Constitution that require VLF to be used for public safety services as defined in that measure. This definition of "public safety services" is not as restrictive as the definition of that same term in SB 89.

The League in its initial brief, filed Dec. 3' argues, in part, that Prop. 30 did not explicitly amend or repeal any of the constitutional provisions relied upon by the League in challenging SB 89/AB 118, and therefore the court is required to harmonize Prop. 30 with these existing constitutional provisions.

The League will have the opportunity to reply to the state's brief, also filed on Dec. 3, by Dec. 17. Once this briefing is complete, the court will take the case under submission, although it is not yet clear when the court intends to issue its decision.

Infrastructure Financing Districts

Updating Infrastructure Financing District law was one of the key recommendations of a League task force formed in 2012, chaired by Pasadena Mayor Bill Bogaard, who now serves as President of the League.

The League worked in a collaborative effort with Sen. Wolk to identify amendments to the law that would make it more workable by removing cumbersome voting thresholds that were not legally necessary, authorizing rehabilitation and maintenance, and other changes. While SB 214 was vetoed by Gov. Jerry Brown, as were several other infrastructure bills, the Governor's veto messages seemed open to the possibility of revisiting the issue. Sen. Steinberg Reintroduces Redevelopment Replacement Tool

Also of interest to cities is the introduction of SB 1 (Steinberg) (http://ct3k1.capitoltrack.com/Bills/13Bills/sen/sb 0001-0050/sb 1 bill 20121203 introduced.pdf). This measure is a reintroduction of last year's SB 1156 (Steinberg), which was also vetoed by the Governor. While the League had various technical and implementation concerns with the final version of SB 1156, we look forward to working with the Senator during this legislative session to help craft a tool that is as useful as possible for cities.

Municipal bond interest is, and has always been, exempt from taxes. This distinction provides a significant benefit to investors, and allows cities access to investors they would not typically reach in the taxable bond market. If the bond interest exemption is either eliminated or capped, the

costs for infrastructure financing for things like schools, roads, sewer systems, bridges and fire stations will increase.

When talking to congressional representatives, cities should stress the importance of keeping municipal bonds exempt from taxes. Representatives should remember:

- Tax exempt bonds fund local infrastructure that creates and supports jobs and competitive businesses nationwide.
- It is imperative that Congress protect the ability of state and local governments to access cost-effective capital through the use of tax-exempt municipal bonds.
- While deficit reduction is important, it is also important that the federal budget is not balanced at the expense of local governments that are already struggling with their own budget challenges.

Legislature Assigns New Leadership, Assembly Member Achadjian New Local Government Chair

This week, both the Senate and the Assembly elected leadership for the 2013-14 legislative session. These legislators will play important roles in the progress of key bills affecting cities. The Assembly also announced its committee chairs; Senate chairs have not yet been revealed. The Assembly Local Government Committee, where many of the bills the League tracks during the legislative session are assigned, will now be chaired by Assembly Member Katcho Achadjian (R-San Luis Obispo), while newly elected Assembly Member Marc Levine (D-San Rafael) will serve as vice chair.

City officials are always encouraged to reach out to their representatives throughout the legislative session to discuss important issues, but establishing early relationships with members is one of the most effective ways to help further the League's advocacy efforts and help cities throughout the state.

ED: Model Demonstration Projects on Promoting Reentry Success Through Continuity of Educational Opportunities

ED has announced a new, nearly \$1 million grant that will invest in innovative programs preparing incarcerated individuals to successfully reenter society with education and workforce training. The purpose this program is to demonstrate the benefits of implementing a reentry education model, as described in ED's November 2012 publication entitled "A Reentry Education Model, Supporting Education and Career Advancement for Low-Skill Individuals in Corrections" (Reentry Education Model). This model is focused on: (1) Supporting individuals, especially low-skilled adults, in their transition from correctional institutions into the community by strengthening and

aligning educational services provided in those settings; (2) establishing a strong program infrastructure to support and improve education services in correctional institutions; (3) ensuring that education is well integrated into correctional institutions by making it a critical component of the intake and pre-release processes, and by aligning it with support and employment services; and (4) encouraging individuals in correctional institutions to identify and achieve education and career goals, recognizing that their education paths are not linear or uniform.

To maximize the public benefit from federal investments in these grants, the Sparks Grants will fund only projects with the following characteristics:
