# LIBRARY BILL, AB 438, MOVES TO ASSEMBLY APPROPRIATIONS COMMITTEE IN MAY

Bill Handcuffs City Council Authority

AB 438, authored by Assembly Member Das Williams (D-Santa Barbara), passed out of the Assembly Local Government Committee on Wednesday and will next be heard in the Assembly Appropriations Committee in May. Opposed by the League, this bill undermines the administrative fiscal authority of city councils by requiring voters to approve a council's decision to provide library services through a private contractor. *For more, see Page 2.*

Libraries serve as a community cornerstone; a place where people gather, come to learn, access the internet, job hunt and much more. However facing economic hardship, city councils are grappling with making tough fiscal choices while preserving critical public services, like libraries. One option for cities to look at is to contract out the staffing services for the library. AB 438 puts a major roadblock before city councils by requiring the decision to contract out services to get voter approval.

The Assembly Local Government Committee's analysis noted correctly that AB 438 sets a dangerous precedent for local government by allowing for the first time a mandatory vote on a city contract. Forcing a vote of the people on a city contract handcuffs the ability of the city to run efficiently.

While the bill passed out of the Assembly Local Government Committee on Wednesday, it must still go to the Assembly Appropriations Committee for fiscal review before it can be heard on the Assembly floor.

The League routinely takes positions on bills throughout the legislative session. Bill's tracked by the League are marked as -watch" until such time that a policy position is taken. Typically, positions are taken early in the year on bills for which the League has standing policy. These policy positions can be found in the League's *Summary of Existing Policy and Guiding Principles* (<a href="http://www.cacities.org/summary">http://www.cacities.org/summary</a>). Bills identified by the League without a standing policy are referred by League staff to one or more of the League's eight policy committees for a policy recommendation and the board of directors for a full position.

## **Employee Relations**

### AB 400 (Ma) Employment. Paid Sick Day. Oppose

Provides that any employee, whether part-time, temporary, or seasonal, who works for seven or more days in a calendar year is entitled to paid sick days, which are accrued at a rate of one hour for every 30 hours worked. This bill does not apply to employees covered by a collective bargaining that provides for paid sick days.

**AB 646 (Atkins) Public Employee Organizations. Impasse Procedures.** *Oppose* Undermines a local agency's authority to establish local rules for resolving an impasse by imposing mandatory fact-finding and mediation under the Meyers-Milias-Bown Act, which will likely delay the conclusion of contract negotiations.

#### Public Safety

## AB 66 (Chesbro) Vehicle License Fees. Support

Extends the 0.15 percent VLF increase for Citizens Option for Public Safety programs, booking fee subventions, and county law enforcement programs indefinitely, deleting the current sunset date of June 30, 2011.

## AB 604 (Skinner) Hypodermic Needles and Syringes. Oppose

Allows the state Department of Public Health to authorize local health clinics to provide needle and syringe exchange services, pre-empting the current local decision making powers of the city or county.

### SB 49 (Strickland) Local Government Emergency Response Fees. Oppose

Repeals local agencies' authority, including charter cities, to levy an emergency response fee except for limited circumstances.

# **Transportation and Public Works**

## AB 1354 (Huber) Retention Proceeds. Oppose

Removes the authority of public entities to decide the appropriate amount of retention. This bill would require that contract retention proceeds not exceed 5 percent of the payment of all contracts between a public entity and an original contractor, between an original contractor and a subcontractor, and between all subcontractors.

### Land Use and Housing

### AB 579 (Monning) Mobilehome Parks: Liability: Attorney's Fees. Support

Allows cities to recover attorney's fees when they have successfully defended their mobilehome rent control ordinance and provides the courts with a special motion to dismiss proceedings that have no reasonable basis.

## AB 1220 (Alejo) Land Use: Cause of Actions: Time Limitations. Oppose

Seeks to change the decision of a Court of Appeal (*Urban Habitat v. city of Pleasanton*). The bill would create a five year statute of limitations to challenge land use planning decisions.

### SB 184 (Leno) Land Use: Zoning Regulations. Support

In response to *Palmer/Sixth Street Properties L.P. v. city of Los Angeles*, seeks to clarify that the Costa-Hawkins Act does not apply to inclusionary housing programs. This would make clear that inclusionary zoning is a permissible land use power.

**SB 444 (Evans) Land Use: Subdivisions: Rental Mobilehome Park Conversion.** *Support* Allows an application to convert a mobilehome park from rental to resident-owned to be subject to all requirements of the Subdivision Map Act, thus allowing local governments the opportunity to mitigate the economic displacement of residents.

## SB 469 (Vargas) Land Use: Development Project Review: Superstores. Oppose

Requires a city or county prior to approving or disapproving a -superstore retailer" to require, at applicant expense, a private consultant to prepare an exhaustive economic impact report examining 17 different detailed conditions. A -superstore" is defined as over 90,000 square feet, selling a wide range of consumer goods, and where 10 percent of the total floor area is devoted to selling non-taxable food items. This measure contains an exemption for -discount warehouses" (with no square foot limitations) that sell over half of their items in bulk and require a membership fee.

#### **Community Services**

### AB 438 (Williams) County Free Libraries: Withdrawal. Oppose

Requires voter approval of a city council's decision to contract out library services to a private contractor.

# Law Enforcement Associations Back Governor's Tax Extension in Appeal to Voters

Representatives of several statewide law enforcement associations, including the California Police Chiefs Association, California State Sheriffs' Association, California District Attorneys Association, and California Probation Officers Association, joined Gov. Jerry Brown at his press conference on Wednesday to speak in support of the tax extensions proposed to be sent to voters sometime this year.

The tax extension includes the Vehicle License Fee (VLF) revenues that are currently, and will continue to be, dedicated to local law enforcement services under realignment. The VLF also represents the most immediate pressing issue for public safety stakeholders because it would extend the soon-to-expire local law enforcement grants for Citizens Option for Public Safety programs, booking fee subventions, and several county level services. The VLF revenue source for these programs will expire on June 30 unless additional revenues are approved.

The Governor dismissed speculation that he would sign any tax extensions passed by the legislature by restating his campaign pledge to let the voters make that choice.

## **Additional Realignment Trailer Bills Drafted**

Two additional budget trailer bills, AB 94 and AB 117, were drafted in response to the Governor's requests and in order to clean up technical issues with the realignment bills, AB 109 and AB 111.

AB 94 was amended to address the Governor's request in his signing message on the jail facility construction bill, AB 111. AB 94 reduces the required minimum contribution from counties from 25 percent to 10 percent of for those construction projects.

AB 117 was also amended to provide technical clean up to AB 109, the main corrections realignment bill, and clarify errors that conflicted with voter approved initiatives and Division of Juvenile Justice sentencing.

The Governor signed AB 109 and AB 111 earlier this month without a dedicated funding source being identified to pay for the corrections programs they seek to establish. His signing message included a pledge not to enact any of the changes until such a funding source was identified and secured.

Both AB 94 and AB 117 are currently on the Senate floor and have not been scheduled for a vote

# **Congress Avoids Government Shutdown**

Focus Immediately Turns to FY 2012 Budget Discussions

As widely reported, the Senate, House, and White House came to an agreement early this week that will keep the Federal government operating through Sept. 30, 2011, the end of the federal fiscal year. The final agreement included nearly a \$40 billion reduction in federal spending in FY 2011 when compared to FY 2010 spending. This includes \$12 billion in reductions previously approved, and \$28 billion in new spending cuts.

As part of the agreement, the following cuts were made that are of importance to cities:

- Community Development Block Grant Program \$647 million
- State and Local Law Enforcement Assistance \$415 million
- Juvenile Justice Programs \$148 million
- Community Oriented Policing Services programs \$296 million
- Energy Efficiency and Renewable Energy \$438 million
- Clean and Drinking Water State Revolving Funds \$997 million
- Surface Transportation Priorities \$293 million

- High Speed Rail \$2.9 billion
- HOME Investment Partnerships \$215 million

In addition, all domestic discretionary programs, a category description that covers nearly all of the federal funding received by cities, will receive an additional 0.2 percent cut.

#### 2012 Fiscal Year Discussions

On Wednesday, the President immediately turned the discussion toward FY 2012, releasing a fact sheet on his proposal that focuses on —Shared Prosperity and Shared Fiscal Responsibility." The President proposes reducing the deficit by \$4 trillion in 12 years or less with a balance between spending cuts and tax reform. His proposal includes a —Debt Failsafe" trigger that would require that if, by 2014, the projected debt reduction is not realized, there will be an across-the-board cut to federal spending.

The President is proposing to build on the savings from the FY 2011 budget agreement this week, which could lead to additional cuts to domestic discretionary programs.
