

**RESOLUTION NO. 2020-09**

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF IMPERIAL DECLARING  
A LOCAL EMERGENCY FOR THE CORONAVIRUS COVID-19**

**WHEREAS**, health and safety code section 101080 and Chapter 7 of the City of Imperial municipal Code authorize the City to declare a local health emergency whenever the City of Imperial determines that there is an epidemic; and

**WHEREAS**, on March 4, 2020, the Governor of the State of California declared an emergency based upon the threat of the Coronavirus COVID-19 within the State; and

**WHEREAS**, on March 5, 2020 the County of Imperial (“County”) declared a local health emergency throughout the County based on the imminent and proximate threat to public health from the introduction of COVID-19 in the County; and

**WHEREAS**, the City Council of the City of Imperial finds that there is an imminent and proximate threat to public health from the introduction of COVID-19 in the County, for reasons set forth below and that the use of emergency power is warranted to deal with this emergency.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF IMPERIAL,  
CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:**

1. That the foregoing is true, correct and adopted hereby.
2. That this Resolution is adopted and is effective immediately and until such time as revoked by the City Council or City Manager.
3. The City Manager as the Director of Emergency Services, and the Emergency Operations Center Coordinator shall have the authority set out in Chapter 7 of the City Code and as otherwise provided by state law, City of Imperial Emergency Operations Plan and City policies and procedures.
